Summer Homeless Count Data

Lower Grafton County, NH

August 19-21, 2024

Methodology

- Community partners were asked to collect information on all homeless individuals that they interacted with on August 19-21, asking where they spent the night on August 19.
- LISTEN and the City of Lebanon Human Services were the lead agencies for conducting the Summer Homeless Count for Lower Grafton County.
- Approximately 25 volunteers assisted with conducting street outreach to 47 known locations for homeless encampments or homeless services.




Many Vermonters self-reported crossing the river frequently

Where Did You Stay Last Night?




Sheltered vs. Unsheltered














First Time Homeless?



What is the total length of homelessness you have experienced?




Chronic Homelessness

Note: COVID hotel program was in effect in January 2023, and phased out by spring


Recurring Individuals

• Each individual has a unique identifier


First Initial of First Name + First Initial of Last Name + 3rd Initial of Last Name + Last 2 digits of birth year

- E.g. John Doe, born 1970 → JDE70
- **30 individuals** have been definitively identified in multiple counts (out of 186 unique individuals in the last 2 years/4 counts)
 - **10** of them reported residing in both NH and VT across different counts


Sheltered vs. Unsheltered (NH Only)




Where did you stay last night? (NH Only)




First Time Homeless? (NH Only)

Household Income & Environment


- 45 households
 - 35 staying in Lebanon/West Lebanon (or sheltered by Lebanon Human Services)
 - 1 staying outside of Grafton County (SWCS shelter)
 - 9 staying in Vermont
- Second year asking about household income
- Lebanon's DEI Commission's Environmental Justice Task Force request information on how people who are unhoused access and experience their environment
 - Were you displaced by natural/environmental disaster?
 - Has environmental exposure affected health/belongings?
 - Were you denied access to public spaces as a result of your housing status?

DOES YOUR HOUSEHOLD HAVE AN INCOME?



Household Income

- 21 households reported at least 1 income source
- 7 households reported more than 1 income source
- 10 households reported wage-based income
- 10 households reported disability (SSI, SSDI, APTD) income
- 2 households reported Social Security retirement income
- 1 household indicated "donations" as a source of income
- Self-reported monthly household incomes ranged from \$550 (SSI) to \$2,000 (employment wages)

Environment: Displacement

- None of the unhoused community members our volunteers/staff interviewed had been displaced by a natural/environmental disaster
- However...

Not in this instance, but I have been displaced by a natural/environmental disaster in the past I couldn't return to my most recent city because a tropical storm caused massive flooding, which exacerbated the housing crisis/made it impossible to rent there.

Environment:

Has exposure to the environment affected your health and/or belongings?

- 76%, or 34 of 45 households reported some kind of effect on health/belongings
- Only 3 households answered "no," one in a vehicle and 2 were sheltered


